## A new mayor promises anti-crime action

At a meeting with the River Park Neighborhood Association's board of directors three weeks before he was elected mayor of Sacramento, Kevin Johnson urged voters to "please hold me accountable" and toss him out of office in four years if he does not perform adequately as mayor. Johnson noted that his priorities are 1) Public Safety, 2) Education, and 3) Development. But the spurt in crime in River Park was the chief topic of the evening. Asked about the problems at Paradise Beach, Johnson, who admitted to partying there in his Sacramento High School days, said he would meet with sheriff's department and police officials to immediately address the issue. "It is not a hard problem to solve," he said confidently. The candidate also committed to arranging a joint River Park meeting with Sheriff John McGinness and Police Chief Rick Braziel aimed at settling long-standing jurisdictional issues related to the city-owned Glen Hall Park and the county-owned Paradise Beach.



Meanwhile the RPNA board was told that a crime report outlining weak spots in Glen Hall Park should be released soon. Board member Jeff Harris, who has been working with authorities on the report, says it will focus on "crime prevention through environmental design" (CEPTD). Harris said one priority will be improving "decrepit" signs intended to warn park users of rules for both the park, which is closed from sunrise to sunset, and perennial summer problem spot Paradise Beach. Harris added that authorities, who joined him for a lengthy walk-through of the park, like the idea of more lighting and "seem pretty excited about motion-detector lights." He added that the park bathrooms - a sexual assault was reported in the women's restroom in August - are being targeted for makeovers. However, a cyclone fence first proposed two decades ago along the park's southeast perimeter was deemed "weak." Harris noted that a wrought-iron fence - not unlike the fence around the park's pool - would be a sturdier and more aesthetically pleasing choice, but could be very costly at a time when civic funding is scarce.

Neighborhood activist Lee Ruth countered that the portion of a cyclone fence that was installed behind the children's park has proven effective in the 20 years it has been in place near his home. He advocated continuing the fence along the disputed area, which now extends to the H Street Bridge.



October 16 RPNA board meeting

Kevin Johnson had displeased the RPNA board in April when he failed to appear at a well-planned and well-publicized candidates forum. But on October 16 Johnson did indeed show up, addressing the RPNA Board and the few audience members in attendance. Johnson spoke and fielded questions for about 45 minutes. The nattily attired Johnson avoided criticism of Mayor Heather Fargo other than to say she squandered a surplus when one existed in the city coffers on her watch. Instead he invoked the name of the late Mayor Joe Serna as a role model of sorts. Continued on page 4

## Hornet Bookstore beware

### Textbook competitor opens in River Park



**Bookaneers**, which aims to undercut the Hornet bookstore on the CSUS campus, opened for business October 20 in the River Park shopping center space previously used by Bennett's Pastry. Bookaneers owners Fernando and Tamara Figueiredo say they expect slow business most days of the year, but during those few frenzied days when Sac State students are buying (and selling) textbooks for new classes, they expect a line of customers down the street. That's been the experience at their other book store in Davis. Fernando says he'll pay more for used textbooks and sell them for less while making a tidy profit. Overhead is cheaper than at the gorgeous new Hornet Bookstore on campus and the Figueiredos can handle a smaller profit margin. Bookaneers also offers discounts to student groups, fraternities, etc. And there will be promotions -bicycle, scooter, and ipod giveaways for example.

Non-student customers are also welcome. A few bestsellers are now in the window. Once the class book lists are announced, the shelves will fill quickly. The first big student rush is expected in mid-December. Come in now while it's quiet.

# New sign at entrance to Paradise Beach

A bold new sign appeared at the levee entrance to Paradise Beach in mid-October. It declares, in five languages, that all children entering the American River must wear life vests.



River Park activists have long been concerned about the deterioration or absence of proper signage that would warn beachgoers that alcohol consumption, dogs off leash, and after-hours partying are all illegal activities.

The new sign is welcome, both for the content of its message, and for the precedent it sets for future improvements. Meanwhile, the Sacramento Bee reported on October 9 that the city will no longer supply doggie poop bags in Glen Hall Park due to budgetary considerations. The Bee reports that the city thoughtfully will soon install containers at the park into which dog walkers can contribute extra poop bags for others to use.

## Burn if you dare

The Sacramento Metropolitan Air Quality Management District says it's not kidding this winter. Last winter was a dry run, but as of November 1, if you emit wood smoke from your chimney on a "No Burn Day" you may receive a letter of warning. If it happens again, you could be fined fifty dollars.

- **Student Parking** Sac State students are continuing to park, often illegally, in River Park. In mid-October the university placed "Dear Neighbor" door hangers on homes in River Park that are closer to the campus. The message from Sac State parking director Nancy Fox urges anyone with questions to call her at **278-PARK**. Fox wrote that a flier for the offending students' windshields is coming.
- **The fall 2008 River Park general meeting** will take place at Caleb Greenwood School at 3 p.m. Saturday Nov. 22. The RPNA board of directors has decided that this should be a "Meeting of the Minds" at which organizations in River Park can meet together and make plans to coordinate their activities. The PTSO should know more about what the Baseball Club, the Mothers Club, the Garden Club, etc. are doing. Don't miss this meeting.

- **McKinley Village** River Park and east Sacramento in general are slowly becoming aware that developer Phil Angelides' McKinley Village proposal could have a substantial impact on our communities. A tunnel under the UP railroad tracks from Elvas to the new community might not directly impact River Park. But it would definitely increase traffic on Elvas. - **The Cal Expo/ Kings Arena** commission will make its recommendations known soon. A major renovation of Cal Expo plus a huge new basketball coliseum could be in the works.
